Apologies were given and received on behalf of Cllr B Firmin.
- 02 Declarations of Interest and requests for Dispensations
None received.
- 03 Finances – to discuss Banking arrangements and agree action
The Chairman advised that this meeting had been called by Cllrs P.Blencowe, C.Payne and L.Stango as they wanted more information regarding the recent difficulties with Lloyds/TSB Bank.
The Chairman advised that the main issue was that the Lloyds/TSB Bank was going through a period of change, whereby the two banks were splitting, and the Parish Council Accounts had been passed to a new team at TSB.
Both written (copies given to all Councillors) and face to face verbal complaints were made to the Bank. The Chairman read out the Banks response dated 15th August in which a full apology was given, all bank charges were to be waived and an additional £50 to be credited to the account for any inconvenience caused.

After a lengthy discussion it was AGREED to;

- Transfer all accounts back to Lloyds Bank
(new sort code and account numbers will be issued)
- Merge three accounts into one new current account
- Contact three other banks to enquire of their charges/facilities


